Background

- The local NHS has been working for a number of years to ensure local people have access to a range of health services
- We initially planned to refurbish Chase Hospital to bring together GP practices and other services but this was unaffordable for the practices
- Then a new healthy hub became a potential opportunity which we are currently working on
- We have been doing everything we can to ensure local people continue to access a range of services in the hospital
 - The hospital is not closing and offers a range of services
 - It will remain open until there is a viable new health hub



Services at Chase Hospital



A wide range of services are provided at Chase Community Hospital:

- Adult Mental Health Services
- Contraception and sexual health services
- Education services for patients with long-term conditions, e.g. diabetes
- Frail elderly community clinics
- Falls clinics
- Older peoples mental health
- Memory clinics

Developing a health hub, our journey so far



Background


and recent changes to the health hub development



- We applied for NHS capital funding for the health hub. In June 2018 we heard the bid was unsuccessful and are now pursuing a scheme where capital is provided by a third party.
- The location of the Hub was to be moved to a more centralised location in December 2018 by Whitehill and Bordon Regeneration Company
- On 24th January EHDC consulted on the outline planning permission for the health hub (with café and pharmacy) and 70 residential apartments with parking and access roads.
- On 8th March 2019 plans for the health hub were issued by Stride Treglown architecture – the health hub design was put on hold at this point to enable commercial discussions around the financial implications.
- Commercial discussions between the developer and all potential future tenants are ongoing. No agreements to lease are in place, at this time.

Next steps



Planning for the hub is complex, so it will take time

- Continue to work with our partners to explore all funding opportunities
- Finalise discussions with potential tenants
- Finalise costs to be agreed with tenants and the CCG
- Continue to work with partners to develop local services.





Out of Hours Service



Some background



Before 2017

- There was one service providing urgent GP care when surgeries were closed. It was called GP Out of Hours (OOHs)
- In this area it offered home visits, plus face to face appointments for urgent issues at Cowplain

Since 2017

- In 2017 the government introduced an additional new service called GP Extended Access (GPEA) to provide more routine and urgent appointments
- It was open 6.30pm 8.30pm in the week and on Saturdays and Sunday mornings
- In this area it was available at Badgerswood surgery on Saturday mornings and Petersfield, Havant and Waterlooville some evenings/weekends
- The OOHs service was also running as before

So why change?



- Local people have consistently told us that they find access urgent care confusing and complicated
- We knew we had two services running in parallel which is not the best use of our GP workforce
- Staffing all the face to face appointments in a number of 'hubs' was proving difficult
- As a result the hubs did not open consistently, which was confusing for patients
- Both contracts were coming to an end in June 2019
 - We therefore decided to consolidate the two services into one integrated service offer



Bringing provision closer





Under the GPEA/OOHs arrangements:


- 76% of the service hours were provided in the south of the SEH CCG area
- 24% were provided in the north of the SEH CCG area.

Under the integrated arrangements the service hours are provided equally between south and north areas.

Introducing your local Primary Care Network



Primary Care Networks (PCNs)



Newly established PCNs are neighbouring GP practices working together, usually service 30,000 to 50,000 people

- GP contract changes allow practices to enter into a 'network contract'
- Funds will be designated to 'flow' through these new network contracts
- Support transformation work
- 2019/20 is a preparatory year, getting ready for 2020/21
- Phased introduction of key staff groups social prescribing link workers, pharmacists, paramedics
- Developing extended hours, improving access

The East Hampshire PCN comprises of nine practices serving 78,107 local people – Badgerswood, Clanfield, Grange, Horndean, Liphook and Liss, Pinehill, Riverside, Rowlands, Swan
